AFFILIATE STATION AGREEMENT

Please Note: If you plan on airing The Power Hour on multiple AM/FM Affiliate Stations that you oversee, please fill out a separate agreement for each AM/FM Affiliate Station. Thank you!

The Power Hour, a Missouri Radio Broadcast, or otherwise defined as "The Power Hour", and Station Affiliate: _____ hereafter defined as "Affiliate Station" hereby agree to the following:

- (1) The Power Hour will be made available to Affiliate Station on a market exclusive basis, unless this agreement is otherwise amended below. Affiliate Station will air broadcast(s) on the dates and times as specified and outlined hereafter.
- (2) Affiliate Station agrees to provide a signed, and dated copy of this *Affiliate Station Agreement* to The Power Hour before airing broadcast(s).
- (3) Affiliate Station agrees to not defame or in any way cause harm to The Power Hour, and/or its affiliate partners.
- (4) Affiliate Station will notify The Power Hour of permanent changes in broadcast time or schedule within 72 hours of change.
- (5) The Power Hour may request that Affiliate Station furnish a weekly and/or monthly affidavit documenting broadcast time(s), and note any preemption or rescheduling from normal broadcast time(s).
- (6) Affiliate Station agrees to air broadcast in its entirety (as listed in agreement), including network commercials as specified on The Power Hour Program Clock.
- (7) The Power Hour agrees to allow the Affiliate Station exclusivity in licensed market for the broadcast(s) and time(s) addressed on line 10.
- (8) This agreement shall be in effect indefinitely from the date of signing below. The Power Hour or Affiliate Station may terminate agreement on 30 days written notice tendered by either party to the other.
- (9) If The Power Hour or Affiliate Station fails to comply with these provisions or is unable to cure defects in this agreement within ten (10) business days, the injured party may withdraw from this agreement by providing five (5) days notice to the other of their intent to end the relationship.
- (10) The terms above represent the complete terms of agreement between The Power Hour and Affiliate Station, subject only to any amendments if described hereafter: _____
